Organizations or agencies that receive a major grant (i.e., \$2,000 or more) through the Youth Endowment Series for two successive years will not be considered for a major grant in the third year. The goal of the YES program is to have as great an impact as possible in benefiting area young people in a broad range of activities and agencies. Agencies not eligible for a major grant will be considered for a minor grant (usually \$1000).
